### **10 new public invitations to tender in the 7<sup>th</sup> round of tendering for mining concession rights**

The Ministry of Innovation and Technology has issued public invitation to tender for the prospection, exploration and production of hydrocarbon in the areas of Csongrád, Csorna, Érd, Kadarkút, Kisvárda, Nyírbátor, Pusztaszer and Zala-Kelet, for the prospection, extraction and exploitation of geothermal energy in the Gádoros area, and for the prospection, exploration and production of lignite in the Sajókápolna area. **2. Purchase of Tender Documentation, transfer of purchase price and method of receipt (with reference to item no. 10 and 11 of the invitations)**

Purchasing the Tender Documentation is a precondition for taking part in the tendering process. The purchase price of the Tender Documentation is HUF 100,000 (one hundred thousand forints) plus VAT, which must be paid via bank transfer to the Hungarian Mining and Geological Service's appropriation use framework account No. 10032000-01417179-00000000. The purchase price of the Tender Documentation may not be paid in cash and is not refundable in part or in full. When purchasing the Tender Documentation, **the purchaser must also submit a Concession Bidder Identification Sheet in two copies**. The Tender Documentation may be collected at the Customer Service Office of the Hungarian Mining and Geological Service (17-23 Columbus utca, 1145 Budapest, HUNGARY) on working days between 8:00 am and 2:00 pm until the day before the submission deadline. A confirmation of the bank transfer for the purchase price of the Tender Documentation is to be presented upon receipt of the Documentation. The receipt of the documentation is confirmed by the MBFSZ by signing the Application Identification Sheets, from which one copy shall remain with the customer.
